Welcome Barry welcomed all attendees

Minutes of last meeting on Wednesday 16th March 2022. There were no amendments suggested.

Matters Arising Graham said that the branch flyer was not done and he felt it was low priority. The Yahoo to Google transition was progressing well. We now have 29 Mayo branch members some of whom are not BWI members on our email contacts list plus a couple on our WhatsApp but not email. Nathy reported that it's the wrong season for Men's Shed nest box construction! He said that John Lusby could probably do a talk on nest box construction and positioning.

Recent Events Reports from our two events were circulated with the agenda. Barry reminded us that we had 12 events this year of which two were indoor. Both of those were better attended and the prize went to the Gordon D'Arcy talk organised by George with 51 attendees. John felt that this number of events was excessive. He introduced himself as past chairperson and he explained how the branch developed from a local group of enthusiasts undertaking IWeBS counts of Clew Bay and Mayo Loughs. The branch was formed in 2003. He said that his counters were all aging and new counters would be appreciated. Graham mentioned that on our outdoor events there were usually local people attending. Colm suggested that we utilise parish newsletters and other local information networks. This brought the discussion onto our next agenda item.

Role of Public Relations Officer (PRO) Due to Zoom connectivity problems we were unable to discuss this at our last meeting. George had wondered if there was a need for this role with our increasing use of social media. From our experience there was some attendance from people in the area of our events. Hence local promotion would be beneficial.

Appointment of Committee In line with BWI guidelines all committee members should be re-elected annually including officers and all should be paid up BWI members. Barry confirmed that he would be stepping down as chairperson and also from the committee. He would also

withdraw from his administrator roles for our social media platforms but he was happy to continue with our website which he had so ably set up. Barry and Graham confirmed that each of our committee members who were unable to attend this meeting had expressed their willingness to continue on the committee. Barry asked those present both on Zoom and in the RTC if they would continue. All agreed. With regard to officers, Ruth and Graham agreed to continue as joint secretaries, Pádraig as treasurer and George as PRO. No one came forward for the chairperson vacancy.
